Moved by Legislator Rhoads. 8 Seconded by Legislator Muscarella. Anv 9 discussion or debate on the emergency nature 10 of these items? 11 Actually, Kevin, you can give us a 12 presentation on the items themselves that will 13 establish why there is a an emergency. 14 MR. CREAN: Thank you very much. 15 Thank you for considering it as an emergency 16 today. Kevin Crean from the Office Community 17 Development. These are items 117-20, 118-20 and 119-20. They represent supplemental 18 19 appropriations under two grants. Supplemental 20 funding from the US Department of Housing and 21 Urban Development under the Emergency 22 Solutions Grants, Coronavirus Grant and the 23 Community Development Block Grant Coronavirus 24 funding. About eight and a half million 25 dollars in CBDG funding Coronavirus and about

1 Full Leg 5-4-20 2 \$4.2 million under the Emergency Solutions 3 Grant Coronavirus funding. 4 The Emergency Solutions Grant is 5 separated into two different supplementals. б That's why we have three. Two different 7 allocations but that grant is separated into 8 two parts. Which just follows along the 9 process before HUD merged two programs 10 together as we just continue to keep them 11 separate. 12 These funds are specifically 13 appropriated by Congress and signed by the 14 president to push funds out to local 15 communities for items such as food banks, 16 purchase of personal protective equipment and 17 also some supplemental funding for general 18 community development and Emergency Solutions 19 Grants. The Emergency Solutions Grants 20 program specifically addresses the homeless 21 and those at risk of becoming homeless. 22 LEGISLATOR NICOLELLO: Yes. 23 Legislator DeRiggi-Whitton. 24 LEGISLATOR DERIGGI-WHITTON: 25 Ellen wanted to say something.

CREAN: These two programs 9 are already administered by our office. So 10 this is supplemental funding. The rules are 11 generally the same although HUD has waived 12 some of the requirements. For instance, they 13 have waived caps on specific types of funding 14 for different types of activities. But 15 essentially the requirements are the same. So 16 our office that's what we are tasked to do 17 every year is to monitor the use of these So that's no different. 18 funds. 19 Most of these funds will go out to 20 various nonprofit organizations via 21 contracts. So those contracts will be 22 authorized and the payment to the nonprofits 23 will be done by a voucher against those 24 contracts. Those vouchers will be approved by 25 the comptroller's office, checks issued by the

It's the same process 3 that our office follows generally. 4 LEGISLATOR BIRNBAUM: Thank you. 5 LEGISLATOR NICOLELLO: Is there б some sort of expedited procedure that you're 7 going to have as opposed to the general 8 procedures which will take some time? 9 Obviously we want to get these monies into the 10 hands of the nonprofits and others to 11 administer these programs as quickly as 12 possible. 13 MR. CREAN: That's why we asked 14 for the supplemental to be done as an 15 emergency so we can start entering into 16 contracts. Whether we will have an expedited 17 process for the contracts I can't say at this 18 point. But right now we will be submitting 19 the amendment that you approved two weeks ago 20 to HUD for approval. They, hopefully, will 21 have an expedited process, although we have 22 not heard that. 23 We are still waiting for final

23 we are still waiting for final 24 regulations from HUD to come down. But they 25 have encouraged municipalities to submit the

1 Full Leg 5-4-20 2 amendment and to get started with allocating 3 funds in advance of the amendment. 4 Most of the funding that we are 5 authorizing do not require any waivers from б HUD other than the waiver of the cap on public 7 services and that's already been authorized. 8 So we're not looking for anything special on 9 this. 10 LEGISLATOR NICOLELLO: Thanks. 11 But I guess getting this to you today as 12 opposed to two weeks from now it helps the 13 process along. 14 MR. CREAN: Absolutely. This 15 will allow us to enter into contracts and 16 encumber funds. 17 LEGISLATOR NICOLELLO: Anyone 18 else? Legislator DeRiggi-Whitton. 19 LEGISLATOR DERIGGI-WHITTON: So, 20 if someone were to be interested in trying to 21 get funding for like past electric bills that 22 were due what would be the advice to them? То 23 contact DSS? 24 Is this a renter? MR. CREAN: 25 LEGISLATOR DERIGGI-WHITTON: Just

1 Full Leg 5-4-20 2 a constituent. In other words, how are we getting this message out to people that this 3 4 is available? 5 We already had an MR. CREAN: б application portal -- we have a portal under 7 our regular grant funding, so we opened that 8 up to nonprofits and municipalities already. 9 So applications have already been received. 10 But for individuals who are looking 11 to access the funding they can contact my 12 office. We can put them in touch with a 13 nonprofit who may be providing those 14 If it's someone who is at risk, who services. 15 has not been able to pay their rent or not 16 been able to pay their electric utility bills 17 as a result of losing their job or loss of 18 income that's a program we already have in 19 existence. It's the Homeless Prevention 20 program. That's administered out of our 21 office. This is extra funding that will allow 22 us to reach a higher income threshold. So we 23 hopefully will be able to reach more people 24 with that program.

Actually it's C1 in the county. 14 HUD has termed it CV. We termed it C1 because 15 we are expecting a second allocation of 16 funding. That will be C2 when we receive 17 that. 18 LEGISLATOR DERIGGI-WHITTON: 19 Thank you. 20 LEGISLATOR NICOLELLO: Any other 21 legislators? I need a motion to establish the 22 emergency. Moved by Legislator Birnbaum. 23 Seconded by Legislator McKevitt. All in favor 24 of establishing the emergency signify by 25 saying aye. Those opposed? The emergency has
